NOTICE OF RATE AND FORM HEARING

NOTICE IS GIVEN that, in conjunction with promulgating replacement rules, the Superintendent, pursuant to Chapter 59A Article 30 of the Insurance Code, will conduct a public hearing to adopt by Order the rates and forms that are proposed to be removed from the replacement rules. Any Order adopting rates and forms will be contingent upon the Superintendent's action in Docket No. 20-00047-RULE-PC ("rulemaking").

1. The rate and form video/telephonic hearing will be conducted immediately following the rule hearing which commences on November 2, 2020 at 10:00 am.

2. The Superintendent designates R. Alfred Walker to act as the hearing officer for this hearing. Oral comments will be accepted at the video/telephonic hearing from members of the public and any interested parties.

3. Written comments and proposals will be accepted through 4:00 pm on the day of the public hearing, or the last day of the public hearing if the public hearing extends for more than one day. Responses to written comments or oral comments will be accepted through 4:00 pm on November 13, 2020. Scanned or facsimile signatures or electronic signatures conforming to federal and state court requirements will be accepted with the understanding that if there is any dispute regarding a signature, OSI reserves the right to require that original signatures be provided to verify the electronic or facsimile signature. All filings must




